**A.** Surgeries: When surgeons are selected from the Coba pool of providers, there is <u>no</u> deductible or co-insurance. *All surgeries must be pre-Authorized and approved before they are scheduled.* 

**Costs and Benefits:** Because the Coba Surgical Solution is priced very competitively, Kier Construction will pay 100% of the expenses. This may require a change of providers or surgical centers to receive this ZERO out of pocket benefit. Driving a few extra miles could save THOUSANDS of DOLLARS.

**B.** Complementary/Functional Medicine/Holistic & Integrative Health: This treatment covers Bio-Meridian Stress Assessment, Holistic Health Evaluations, Desensitization Therapy, Ozone Therapy, Craniosacral & Therapeutic Therapies, Structural & Visceral Therapy, Muscle Activation, Massage Therapy, etc., along with vitamins, minerals, homeopathy, and other natural remedies.

**Costs, Limits and Benefits:** Employees have a \$25 co-pay for office visits and \$15 co-pay per remedy.

C. Prolozone - This therapy treats mild to moderate musculoskeletal issues. Prolozone is a combination homeopathic/oxygen treatment that is injected into damaged joints or tissues.

**Costs, Limits and Benefits:** Employees have a \$35 co-pay.

D. Prolotherapy - This therapy treats mild to moderate musculoskeletal issues. Prolotherapy is typically a dextrose solution that is injected into damaged ligaments and joints to trigger the body's natural healing response.

**Costs, Limits and Benefits:** Employees have a \$35 co-pay.

E. Regenerative Medical treatment (Platelet Rich Plasma (PRP), Amniotic Fluid Injections, Stem Cells, etc.) – Lite. This treats mild to moderate musculoskeletal issues.

**Costs, Limits and Benefits:** Employees have a \$50 co-pay.

**This treatment:** The appropriate levels of either PRP or New Life Regenerative Medicine (Stem Cells) are injected into the damaged joint or tissue.

Regenerative Medical Treatment (Platelet Rich Plasma (PRP), Stem Cells, etc.) – Full.

This is a treatment for more serious muscular-skeletal issues such as severely torn tendons, ligaments, muscles, and bone on bone joints.

**Costs, Limits and Benefits:** Employees have a \$50 co-pay.

H. Functional Cancer/Lyme Treatment

The cost for this supplement from Life Health Center is \$15 per box and treatment normally requires 2 boxes per month for 12 months.

I. IV Therapy - This therapy is used to infuse the body with vitamins and nutrients directly into the blood stream. The intravenous method is the fastest way to deliver medications and fluid replacement because the circulation carries them throughout the body. Intravenous therapy may be used for fluid replacement (such as correcting dehydration), to correct electrolyte imbalances, to deliver medications, vitamins and or nutrients.

**Costs, Limits and Benefits**: Employees have a \$15 co-pay for the IV remedy. Allowed limit is \$150 per treatment.

J. Genetic/DNA testing for Gene to Drug, Drug to Drug, and Food issues – Different levels of Genetic testing are available based upon the individual needs of the patient.

**Costs, Limits and Benefits**: Employees pay a 10% co-Insurance and the Plan will pay the balance up to a limit of \$1,800.

**This treatment includes:** A simple collection of saliva is required. A report is generated that allows the patient and their physician to understand how their body responds to drugs and foods. A customized treatment plan is created based on the results of the DNA test.

**K. Bio-Identical Hormone Pellet Implantation for Hormone Replacement Therapy -** This therapy is used to deliver bio-identical hormone that are inserted into the body.

**Costs, Limits and Benefits**: Employees have a \$25 office co-pay and a \$15 co-pay for the remedy. Allowed limit is \$300 per implantation. Employees have a \$25 office co-pay for a Pellet Booster, if required.
